

**Camden Town Council Meeting**  
**June 14, 2017**  
**Camden-Jackson Twp. Library, Reading Room**

Following the Pledge of Allegiance, Mr. Robison called the regular meeting of the Camden Town Council to order at 7:00 p.m. Present were Members Brent Deel, Mark Schock, Andy Robison, Deputy-Clerk Treasurer Lynette Martin, Attorney Anne Briggs and six guests.

Motion to approve the minutes from the May 10<sup>th</sup> Regular Meeting was made by Mr. Deel, seconded by Mr. Robison. After a review of the claims, Mr. Schock made the motion to approve the June Docket & Allowance Docket as amended with handwritten claims which was seconded by Mr. Deel and passed.

Mr. Robison made a motion to table the Request for Qualification, seconded by Mr. Deel.

Pete Wagoner gave a brief update on the GEP Project.

Department Reports

Utility/Street Superintendent, Jerry Snively, gave an update on the street work and the trees being taken down. The Council asked Jerry to get a price on the tree at 289 N Church Street which has to be removed due to causing the property owner damages to his car. He has ordered new speed limit signs.

Mr. Schock made a motion to reapply for the storm sewer grant. The motion was seconded by Mr. Deel.

There was some discussion on when and what sticks are picked up by employees. The Council asked for research on how other small towns handle their brush pick-up.

The Marshal's Report was read aloud by Mr. Dunning. Mr. Dunning asked about the status of the Reserve Program. Mr. Deel made a motion for Attorney Anne Briggs to begin the paper work for a Reserve Officer. Motion was seconded by Mr. Robison. Anne will have an ordinance ready for the July Meeting.

Mr. Schock made a motion to table the generator contract for Buckeye Power, seconded by Mr. Deel. Mr. Schock also made a motion to table the Contract with Ice Miller and Umbaugh, seconded by Mr. Deel. A meeting will be set up for discussion on these as well as the 2018 Budget.

Mr. Schock made a motion to open bids for the Housing Grant on August 9<sup>th</sup>, and to award the project on August 29<sup>th</sup>. Motion was seconded by Mr. Deel.

There was discussion on the bids for work at the Med Center noting only one bid was received. Mr. Schock made a motion to accept the bid from Lee's Plumbing to do the plumbing work in the exam rooms. Motion was seconded by Mr. Deel.

Mr. Schock made a motion to accept a bid from ABC Concrete for sidewalk work on East Main Street. Mr. Deel seconded the motion to accept.

Mr. Schock made a motion to accept Ordinance 2017-5 Establishing Local Roads & Bridge Matching Grant Fund, seconded by Mr. Deel.

Mr. Deel made a motion to accept Ordinance 2017-6 Amending Salary Ordinance 2016-5, seconded by Mr. Schock.

Mr. Schock made a motion to accept Ordinance 2017-7 on Fireworks, seconded by Mr. Deel.

Mr. Schock made a motion to repeal Ordinance 2017-3, seconded by Mr. Deel.

Mr. Robison made a motion to pay \$50.00 to Mr. Schock for a refrigerator for the Community Center. It was seconded by Mr. Deel.

#### Old Business

There was no old business.

#### Misc.

Thank you to Barbara McCain and the Preservation Society for the work in securing an historical marker at the school.

Jackson Twp. Received \$391 for the first 2 dumpsters of scrap metal and have one more check coming for the third load.
