ORDINANCE # 2019-3

AN ORDINANCE VACATING A PORTION OF ROADWAY

BE IT ORDAINED AND ENACTED BY THE TOWN COUNCIL FOR THE TOWN OF CAMDEN, CARROLL COUNTY, INDIANA, AS FOLLOWS:

WHEREAS, Indiana Code 36-7-3-12 grants unto the Town Council for the Town of Camden, of Carroll County, Indiana, the power and authority to vacate public ways; and

WHEREAS, that notice of said vacation proceedings was properly given as by law provided; and that the matter was properly before the Town Council of the Town of Camden, of Carroll County, Indiana; and

WHEREAS, after hearing upon said Petition To Vacate, finding no person objecting or remonstrating feeling himself aggrieved by the proposed vacation, the Camden Town Council determines that the proposed vacation should be granted.

AND NOW THEREFORE, BE IT ENACTED BY THE TOWN COUNCIL OF THE TOWN OF CAMDEN OF CARROLL COUNTY, INDIANA, THAT:

All that portion of an unnamed roadway South of Lots 9 and 14 and North of Lots 8 and 15 and an unnamed alley East of Lot 8 and West of Lot 15 and in the Will R. White and Company Subdivision in the Town of Camden, Indiana.

and so set forth in the petition instituting this proceeding be and hence forth stand vacated; that the public easement and right-of-way thereover and therein is hereby held and declared to be at an end; that title to said portion of the roadway by this ordinance vacated revert to and remain the sole and separate property of the owners of the lots which adjoin said portion of the roadway so vacated, and as such, owners of the former servient tenement in said roadway are

now hereby vacated; that such ownership is now free and clear of the former public easement and right-of-way; that said public easement is hereby terminated; and that said portion of the roadway so vacated may be hereinafter used by said owners in any manner that the same would have been formerly usable, had the right of public use and travel, now terminated, never exited.

The invalidity of any section, clause, sentence or provision of this ordinance shall not affect the validity of any other part of this ordinance.

This ordinance shall be in full force and affect from and after the 17th day of June, 2019.
