**ORDINANCE # 2017-1  
REGULATING GOLF CARTS  
REVOKING ORDINANCE # 2015-1  
AMENDED JULY 14, 2021**

WHEREAS, Indiana Code 9-21-1-3.3 provides (in part) that a town may adopt an ordinance regulating the use of golf carts on a highway under the jurisdiction of the town,

It is now ORDAINED by the Town Council of Camden, Carroll County, Indiana, as follows:

**Section 1:** Each owner of a golf cart (hereinafter “vehicles”) operated on the streets and alleys of said Town of Camden, Indiana, shall:

- a). Annually complete an application for submission to the Camden Town Marshal’s Office.
- b). Provide proof of insurance to the Clerk of the Town of Camden, Indiana.
- c). Pay a registration fee of \$25.00 which shall be deposited in the General Fund of said Town.
- d). Provide proof of age over sixteen (16) years of age when requested to do so by the Clerk or Town Marshal of the Town of Camden.
- e). Provide a valid driver’s license for examination by said Clerk or Marshal.
- f). Acknowledge in writing that said owner has received a copy of this Ordinance and will abide by the requirements herein.

If the owner a golf cart has complied with the above and afterwards transfers ownership, the successor owner, also, must comply with the above requirements before operating said vehicle as provided herein in order to be in compliance with this Ordinance.

**Section 2:** Upon completion of the above requirements, said Clerk shall provide a decal displaying the month and year of expiration of registration with an assigned number for registration purposes. At all times, said decal shall be displayed on the left rear corner (driver’s side) Or front window of said vehicle.

**Section 3:** Said vehicles shall **not** be operated or parked on the following streets:

- a) All of Main Street (State Road 218)
- b). The portion of South Water Street designated as part of State Road 75.

However, said vehicles may cross said streets at a 90 degree angle after assuring that no other cars or trucks are within the immediate vicinity. Said vehicles shall obey all federal, state and local regulations and ordinances governing passenger automobiles, including but not limited to laws, regulations and ordinances relating to the licensing of operators.

Said vehicles may be operated on the streets and alleys in the Town of Camden, Indiana, unless prohibited herein but shall not be operated on the sidewalks..

**Section 4:** Said vehicles shall be driven as close to the right edge of the street or alley as possible and will yield to vehicular traffic in order not to impede or block the normal flow of traffic.

**Section 5:** There are two types of permits golf carts, namely a **General Use Permit** and a **Dawn to Dusk Permit**.

Requirements for all off-road vehicles are:

- a) Working head-lights, tail-lights, brake-lights, amber flashing-light on top. Said vehicles without working head-lights, tail-lights and brake-lights may not be operated after dusk.
- b). The vehicles must have a regulation-size slow-moving vehicle sign visible from the rear day and night which complies with requirements established by the State of Indiana.

- c) . All seats must be firmly attached to the vehicles.

In addition to the above, requirements, the **Dawn to Dusk Permit** vehicles must have an amber flashing light on top to be in use when the vehicle is being driven.

**Section 6:** All other forms of recreational vehicles, such as ATV's, go-carts, snowmobiles, etc. are not permitted to be operated on the streets of the Town of Camden, Indiana.

**Section 7: Penalties:**

- a). Any person, firm or corporation who violates or permits a violation of any provision of this Ordinance shall pay a minimum fine of Fifty Dollars (\$50.00) on a **first** violation and on a **second** violation during an annual registration period, shall pay a fine of One Hundred Dollars (\$100.00). Said fines shall be deposited in the General Fund of the Town of Camden, Indiana.
- b) If a person, firm or corporation violates or permits a violation of any of the terms of this Ordinance for a **third** time during a single annual registration, said registration will be revoked and operation of said vehicle will not be permitted for a period of one year commencing with the date of the third violation.
- c). Any vehicle registered for a Dawn to Dusk Permit, which allows for daytime use only of the vehicle on the Town's streets, will be in violation of this Ordinance and subject to the fine and penalties stated herein if the vehicle is on the streets or alleys during any other time.
- d). If a vehicle is operated with a revoked registration, a fine of Two Hundred Dollars (\$200.00) will be assessed.

**This Ordinance shall be in full force and effect after its passage and publication as required by law.**

**Ordinance # 2015-1 is hereby REVOKED.**


**Ordinance # 2017-1 is hereby AMENDED.**
